ACTION: Karin moves and Dan seconds the motion to approve August 2012 minutes with no changes

PRESENTATION

Luciano Chiaramonte, Salmonid parasites in the Willamette River

Discussion of the temporal and spatial distribution of Ceratomyxa Shasta in the Willamette River – a study of Salmon disease. 2010 Sampling. Ceratomyxa Shasta is a microscopic parasite that uses Salmon or trout as its host. This parasite study is important because of the threatened species listing of Chinook and Steelhead runs in the Willamette River. The parasite causes intestinal hemorrhaging and bloating of the fish. The fish can be affected at all life stages. This study was conducted from the main stem of the Willamette River in Eugene all the way to the mouth of the Columbia River in various places, as well as in the Klamath River basin. Summer salmon runs evolved with this parasite as they migrate through the rivers, but with higher concentrations of the parasite in the water now, due to lower water levels from anthropogenic causes, the fish cannot accommodate it.

Projects Update

Wendy Sparks- upper Luckiamute side channel reconnect Rack proposal for Upper Maxfield Creek

Japanese Knotweed = extent goes from the mainstem and Pedee to below 99, and also on the Lil Luckiamute. We should pursue a knotweed grant outside of the Model Watershed for Lil Luckiamute and mainstem knotweed control. This will tie into the MMT work. \$175,000, proposal – mid to late October, by Oct 22^{nd} . Peter is very familiar with knotweed and how to mitigate, he'll make a proposal and let us know at the next meeting.
