Executive Committee Report

<u>Review OWEB Biennial Self-Assessment Responses</u> – See attachment, Feb. 8, 2018 packet.

ACTION: Reviewed responses from the self-assessment, required by OWEB. See file in meeting packet. Council must choose 4 areas to OWEB to address during the coming biennium – Reviewed items, including the following, ranked 1 to 4 (4 is highest). The council chose to pursue the 4 **bolded** items, specifically because they fit into our priorities and work plan:

- Capacity assessments (financial skills, council ranked at (3)
- Organizational measurements or tracking discussed monitoring projects, finances and events. Can we have measurable warnings and metrics that predict success and failure, Mark asked. Quality of output, predictive measures is that possible? Kristen answers: We have simple metrics as we go through projects. Some grants have reviews. (2)
- Program relevance and integration do we get sidetracked? Do we take advantage of opportunities. Council agreed that we are working to complete our mission. (3)
- Financial planning and budgeting, chose (3);
- Standard operating procedures (2) some procedures for finances, science tests. Patrick says he will bring in policy and procedure manuals. Students interested in volunteering to help create these? Ask Suzanne to include in WOU volunteer event Feb. 15
- Volunteer management Ideas for how to recruit volunteers, chose 2. Need training.
- Website some improvement needed (3) has improved but interaction needed, Spanish needed.
- Organizational evaluation was ranked at (2)
- Community presence was a (2)
- Community involvement/engagement ranked at (2)
- Dependence on ED too much, need more members, volunteers, staff, bring in recruitment also a (2)
- Funding model getting better, working on it (1)
- Legal Help (2)

<u>Model Watershed Intel Encore Fellow</u> – See Attachment E in the Feb. 8 baord packet

A program for retirees paid for by BEF and Meyer aimed at researching common problems shared by at least two councils, and how to help address those problems.

Including: Efficiencies discussed, shared work and equipment, event planning. Discussed example, JP project manager for three watersheds, with and a tech assistant, Tori, who now works in our watershed.

Willamette Anchor Habitat Working Group

Kristen has a powerpoint including history of the group, beginning with Willamette River Initiative in 2008, became the SIP Special Investment Partnership, then Bonneville joined the funding, 2010, became FIP (Focused investment Partership) in 2015

The LWC is part of the working group.

Working group chose to stick to SIP focus -6 years of funding for the LSNA, one project for flood plain reconnection.

But ... Partnership no longer has a leader. Kristen was asked to take a leadership role. About a .3 or .4 FTE, relatively secured funding from OWEB, but not completely funded. She discussed pros and cons:

Leadership role

Would have to restructure staff
