7:05 – 7:10 Public comments / Mission Moment

All present

Dave E – Watershed Moment – request by his son - ideal temperature for salmon – Dave said 18C – son said, no, tell me what temperature! To *cook* salmon...

Dan F – Mission Moment - Luckiamute Confluence Tour included Jont Creek, with a section with water backed up by a beaver dam that contained many small fish, a wildlife biologist had come out and caught a number, including a green sunfish, a new invasive, and Oregon chub, delisted from the endangered list, with others. Seeing all these fish where the creek was all but dry upstream made it clear what we are trying to do – preserve this habitat for all the many creatures and life there – fish, newts, crawdads, beaver, plants – despite all the time spent on business, finances, projects, LWC is not about the business but about the life in the watershed.

Business:

7:10 – 7:13 Approve Investment into CD with Edward Jones – Action Item, Dan, Treasurer Discussion of alternatives for the future, Ally Bank and Barclay's mentioned, as possibly having better rates. May require a year commitment. This is a 3 month & 6 month trial to see how this works.

Action: Authorized opening an account with Edward Jones for investment purposes. Authorized the Treasurer and Executive Director, currently Dan Farnworth and Kristen Larson, to be the authorized representatives on the account.

7:13 – 7:15 New Vendor for Online Bill Pay Approval – Action Item

Funds for retirement accounts said they could do automatic withdrawal for retirement, turned out when it was time to set up that they couldn't & have to write a check every month, online payment much easier.

Action: Approved using online bill pay from OSCU Checking account to Calvert for disbursement of retirement funds.

7:15 – 7:20 <u>Submission of Monitoring Grant Proposal</u> – Action Item, Attachment B, Kristen With temperature monitoring can have a field verify check on thermal – can't do enough points to calibrate the NetMap model, which is used to identify high priority project sites. However, can get some data points to get some increased confidence in conclusions.

Action: Authorized submission of Monitoring grant proposal to OWEB for continued temperature monitoring and sharing of data

7:20 – 8:00 8:20 Review of Draft 2019 – 2022 Strategic Plan – Discussion Shawn, Consultant

Shawn Morford joins remotely to review the draft and collect Board feedback. Kristen taking notes. Hope to collect comments and have a final version to approve at November Board meeting. Reviews document with the group. Kristen also talked briefly about the focus group meeting with targeted local landowners on the strategic plan, generally favorable response to items discussed; beaver benefit to healthy watershed, information on salmon-safe or forest management certifications that can add value to products, residential homeowner water conservation, build partnerships. <u>June 2018 Fiscal Year End Reports</u> – Attachments C & D, 25 minutes

First year as 501(c)3 entity, and LWC controlled their own funds and have full fiscal information available for year end report. Presentation and discussion. Fundraising – made more money than FY17, cost more money too. Operating & Administrative Costs, how to pay, had some grants plus fundraising. Meyer Memorial grants covered 25% of costs and although some funds remain to be spent there will not be more grants. Challenge is next 2 years – need to cover elsewhere to maintain the current level of service: donor willing to provide capacity grants (low likelihood) or target for fundraising

Judy Beebe willing to answer questions – equity handout, sample balance sheet. Assets – liabilities = equity, for individuals and for LWC. Can change names. Can add a column for set-aside, restricted from use funds, if desired. Won't change the equations or the totals. Don't need over/under billing form of accounting because ultimately report to the IRS in form 990 on a cash basis, not accrual basis.

Level of financial reporting at Board meeting up to Board but since have a Finance Committee reviewing in more detail, less detail should be acceptable as long as Board is satisfied Finance Committee is doing its job (she sits on it and says they do).
