## Reflecting on Eleven Years of Stewardship at the LWC

When the Oregon Plan for Salmon and Watersheds was adopted in the late 1990's, one of its core tenets was "community-based action". Local groups such as watershed councils were recognized as critical to getting the work done on a local level and achieving community-based actions on a voluntary and collaborative basis.

The Boards of watershed councils are designed not only to reflect the geographic range of the area a council serves, but to reflect the range of interests, land uses, and perspectives in the community. By design, a watershed council is intended to bring together diverse voices and perspectives to identify priority problems, work out an agreed upon solution, and make the solution happen – in a voluntary and collaborative way. This is not simple or easy. But when it works, it is a beautiful thing that strengthens community and results in lasting changes.

The community-based, voluntary model of watershed councils is what drew me to this work. My personal statement to apply to Oregon State University for graduate school was focused on getting my master's degree and going on to work for a watershed council because I believe in this model.

Over the last 11+ years, I have been continually inspired and humbled by the remarkable communities of the Luckiamute and Ash Creek watersheds – people voluntarily opening up their properties to us for on-the-ground restoration work, the volunteers, donors, and experts

who share their time, treasure, and expertise, our partners who share in the struggles and successes of the work, our dedicated Board and committee members who give so much and work behind the scenes to support the overall organization, and our amazing staff who help make it all happen.

### **Cultivating Harmony: Vegetation Management for Beaver Coexistence**

George Kral, owner of Scholl's Valley Native Nursery, will delve into how to manage vegetation to effectively coexist with beavers. He highlights strategies for attracting beavers by planting trees and shrubs that serve as their preferred food sources. Additionally, he explores planting techniques that can discourage beaver activity in areas where their presence is undesirable. George's observations and lessons learned over decades of practice will provide

valuable insights for landowners, natural resource managers, and anyone interested in promoting sustainable coexistence between beavers and humans. By understanding beaver behavior and employing effective vegetation management strategies, we can minimize conflicts and reap the benefits of these ecosystem engineers.

### Secrets of the River: The Weird and Wonderful Lives of Oregon's Native Freshwater Mussels

Oregon is home to several kinds of native freshwater mussels, a type of burrowing bivalve found in our rivers and streams. These animals are incredibly important for clean water and healthy fish populations, as they filter pollutants from our waterways and support complex habitats and food webs. However, they are easily and commonly overlooked. These unique animals are characterized by a bizarre life cycle, during which they may spend up to a hundred

years filter feeding in the bottom of a stream, but begin the first few weeks of their lives as specialized parasites of fish. This presentation will introduce you to these incredible mollusks and share more about where they can be found, their need for special conservation, and what you can do for these fascinating animals.
